MY STATEMENT IS AS FOLLOWS:

- **Are you/and your partner still planning to have more children?**
Yes we are; we would love to have two more children.
- **If not, do you have friends/family that will be affected if homebirth is not an option for them?**
Yes friends of ours and family members want to have homebirths with a midwife in the near future.

- **Will your local hospital be likely to provide a homebirth program?**
More than likely not. They are a very conservative hospital and do not provide services that are woman centred. My wife could not have a water birth in hospital with our first child and she is still very upset by this. She really wanted to have a water birth and they would not allow it because they did not have a policy for it. They didn't care about what she wanted for her and our baby. So our decision to have a homebirth second time around has been wonderful for my wife, our children and for me.
- **If you are planning to have more children, will you want to choose homebirth?**
Yes we want to have more children at home with a midwife. I had some doubts at first when my wife wanted to birth at home for our second child, but after having such great care from our private midwife, I can't imagine my wife birthing anywhere else. It was very special for all of us. I know that when it comes to birth it really is about my wife and our baby; however I also think it is important that you all understand that my own feelings were important as well. Having our second child at home, I felt so much more comfortable, than when we were in the hospital with our first child. I didn't have the stress of the drive into hospital, and I could relax on the couch and be with my wife. It was an amazing experience.
- **What will you do after July 2010?**
